Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. This also applies for professional development and staff gatherings. As cohort groups increase in size, the risk of spreading disease increases. <ul style="list-style-type: none"> ☒ Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week⁴, unless the school is offering Learning Outside, then they must follow guidelines for cohorting in Learning Outside guidance. Schools must plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. COVID-19 symptoms are as follows: <ul style="list-style-type: none"> • Primary symptoms of concern: cough, fever (temperature of 100.4°F or higher) or chills, shortness of breath, difficulty breathing, or new loss of taste or smell. • Note that muscle pain, headache, sore throat, diarrhea, nausea, vomiting, new nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC. • In addition to COVID-19 symptoms, students must be excluded from school for signs of other infectious diseases, per existing school policy and protocols. When staff are exhibiting primary symptoms of COVID, they are to stay home and contact their supervisor immediately. The supervisor will work through the ODE Planning and Responding to COVID scenarios to determine next steps.</p> <ul style="list-style-type: none"> • Assigned staff will be outside of the building as students arrive • Staff will be trained to recognize signs and symptoms of COVID-19 • If students exhibit symptoms, staff will respond by following protocol (remaining with their guardian and not entering school or moving directly to the isolation room and sent home as soon as possible) <p>The final decision for duration of exclusion is made by UCoH. - Staff and students will wash/sanitize their hands upon entry/exit.
