ENROLLMENT REQUIREMENTS

#1. ENROLLMENT PHOTO

- Official Enrollment photos will take place at gear check out - but will still need headshot photo to complete registration.

#2. BIRTH CERTIFICATE

- Three points of reference must be verified on the Birth Certificate document.

1. *Player's Full Name*
2. *Player's Date of Birth*
3. *Player's Parent name*

***Note: In the event of foster care, court order or another guardian that would reflect the enrolling parent not matching parent name on the birth certificate, additional documentation will need to be submitted to insure the proper adult is signing the waivers for league liability & insurance purposes.

✓ Acceptable Documents:

- Certificate of Live Birth*
- Passport (Can't be expired)*

✗ Non-Acceptable Documents:

- Hospital Certificates*
- Social Security Card*

#3. GRADE VERIFICATION

- Four points of reference must be verified on the Grade document.

1. *Player's full name*
2. *Player's School Name*
3. *Player's Grade (can reflect previous year)*
4. *School Year*

✓ Acceptable Documents:

- School ID/Report Card*
- Student Online Account Profile*
- School Document clearly shows the 4 points of reference.*

#4. ADDRESS VERIFICATION

- Four points of reference must be verified on the Address Verification document.

1. *Name on Utility Bill* - Must match a parent/guardian name on the Team Sideline account
2. *Address on Utility Bill* - Must match address on Team Sideline account.
Service address is recognized over mailing address. (PO Box is NOT acceptable)
3. *Billing Date* - Billing date must be within 90 days of registration.
4. *Utility Company Name*

✓ Acceptable Documents:

- Water*
- Sewer*
- Garbage*
- Gas*
- Power company*

***Note: option if all utilities are paid by the landlord of the residence is a rental/lease

✗ Non-Acceptable Documents:

- Cell Phone Bill*
- Internet*
- Cable*
- Medical Bill*
- Tax statements*
